



## Dean's Scholarship (No Application Necessary)

The Dean's scholarship is offered to students in the Master's Program who have achieved academic excellence. Students entering the 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> semesters in Fall 2023 will be evaluated and chosen based upon academic merit. Non-degree students or students who receive full scholarships from external institutions (GKS, POSCO, etc.) are not eligible for the Dean's scholarship.

\* **Dean's list and Dean's scholarship are different. (Those who are on Dean's list might not get the Dean's scholarship.)** Depending on the budget for the semester and the academic performance of the students on the list throughout the semester, scholarships will be given to the top-ranked students. Therefore, not all students on the Dean's list will be able to receive it.

### 1. Eligibility

- A. Full-time students during the Spring 2023 semester (**minimum 12 credits**) with a **GPA of 4.0/4.3 or above**
- B. Full-time students who are entering their 2nd, 3rd, or 4th semester in the Fall 2023 semester
- C. Only students who have fulfilled the core course requirements (including those who could waive core courses) are eligible for the Dean's scholarship.

**2. Evaluation Criteria:** Spring 2023 GPA, Number of credits, CGPA, etc.

**3. Amount:** 50% - 100% of tuition

**4. Announcement of the Final Result (Expected):** middle of August, 2023 by e-mail

\* Students who will take a leave of absence during the Fall 2023 semester will not receive the Dean's Scholarship.

## Financial Aid (Application Necessary)

Financial Aid is offered to students in the Master's Program who have achieved academic excellence and are in need of financial aid. Students entering the 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> semesters in Fall 2023 will be evaluated and chosen based upon academic merit and financial need. Non-degree students or students who receive full scholarships from external institutions (GKS, POSCO, etc.) are not eligible to apply for financial aid.

### 1. Eligibility

- A. Full-time students during the Spring 2023 semester (**minimum 9 credits**) with a **GPA of 3.5/4.3 or above**
- B. Full-time students who are entering their 2nd, 3rd, or 4th semester in the Fall 2023 semester
- C. Only students who have fulfilled the core course requirements (including students who were able to waive core courses) are eligible to apply for financial aid.

**\* Applications without enough supporting documents could be disqualified.**

**\* Students who take a leave of absence during Fall 2023 are not eligible to apply.**

**2. Evaluation Criteria:** Spring 2023 GPA, demonstrated need for financial assistance, etc.

**3. Application Period:** Wednesday, July 12, 2023 – Tuesday, July 18, 2023

**4. Amount:** 1/6 - 1/3 of tuition

**5. Announcement of the Final Result (Expected):** middle of August, 2023 by email

**6. Method of Submission:** In person at GSIS office, post, or email(gsis@yonsei.ac.kr)

**7. Application Documents / Requirements:**

### For Korean Students:

- B. 지원서 (첨부 양식) 1 부
- C. 장학금 신청사유서 (1 ~ 2 페이지 분량의 자유 양식)
- D. 주민등록등본 또는 부모 명의 가족관계증명서
- E. Agreement for Collection and Use of Personal Data (첨부 양식)
- F. 지방세 (재산세, 종합토지세) 세목별 과세증명서 1 부
  - 1) 타 지역분 포함, 본인 및 부모 모두 제출
  - 2) 원칙적으로 5 만원 이하인 자만 가능
  - 3) 과세 사실이 없는 경우에도 반드시 제출 (미과세증명서 제출)
- G. 근로소득원천징수영수증 1 부
  - 1) 본인 및 부모 모두 제출



- 2) 직장인일 경우 제출하며, 원칙적으로 연간소득 2,400 만원 미만인 자만 가능 (해당 직장에서 발급)
- H. 지역건강보험료납입증명서 1 부
- 1) 본인 및 부모 모두 제출
  - 2) 직장인이 아닌 경우 (자영업자, 기타 등)만 제출  
(단, 피부양자의 경우 건강보험자격득실확인서로 제출)
  - 3) 원칙적으로 4 만 5 천원 이하인 자만 가능 – 건강보험관리공단지부에서 발급
- I. 기타 가계 곤란을 증빙할 수 있는 서류(학자금 대출 증빙서류 등)
- \* 위의 원칙적인 기준에 해당되지 않더라도 서류 제출 가능
  - \* A, B, C, D, E, F 는 공통 필수 제출 서류이며, 근로소득자의 경우 F, 자영업자(농, 어업종사자 포함)의 경우 G 의 서류를 반드시 제출
  - \* 특별한 사정이 있어 부모와 독립하여 스스로 학비를 조달해야 하는 학생의 경우에는 사유서에 이를 자세히 밝힐 것
  - \* 국민기초생활보장법에 의한 기초생활수급자 및 차상위계층인 가정은 장학금 신청서와 해당 증명서만 제출

**For Non-Korean / International Students:**

All documents should be submitted **in English or in Korean**.

**[REQUIRED]**

- A. Online application form (Naver form, <https://naver.me/xoK0Gm64>)
- B. Completed Application Form (form attached)
- C. Personal Statement (freeform of 1 - 2 pages) explaining your need for financial assistance
- D. Agreement for Collection and Use of Personal Data (form attached)
- E. Copies of Income Statements from both of your parent(s) or guardian(s) for the last six or twelve months + Explicitly state their monthly or annual income
- F. Copy of the Certificate or Proof of Income Deposit of your Part-Time Work (only applicable if you have a part-time work)

**[Submit one or more of the following]**

- G. Documents Demonstrating Financial Need. Examples are as follows:
  1. Copies of Student Loan, Credit Card, or Banking Statements for the past six to twelve months
  2. Copy of your Lease / Housing Agreement in Korea



3. Copies of Tax Statements from both you and your parent(s) or guardian(s) if applicable
4. Copies of Unemployment or Bankruptcy by both you and your parent(s) or guardian(s)
5. Other income/asset/financial information documentation

\* The more supporting documents you submit from option G, the higher your chance of receiving financial aid will be.
